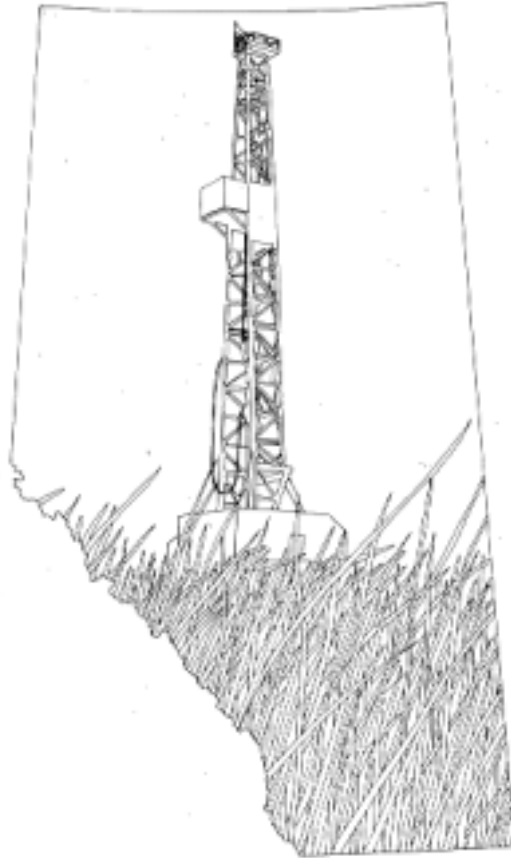

AMOUNT OF PAYMENT

1. Your bid letter should mention only the one total dollar amount consisting of bonus, rent at \$3.50/ha or \$50.00, whichever is greater, and a fee of \$500.00.
2. An offer of less than \$2.50/ha for a lease or \$1.25/ha for a licence will not be considered.
3. The department reserves the right to reject any bid.

FORM OF PAYMENT

1. Only by electronic funds transfer (EFT).
2. Payment by cheque will only be accepted if it meets the criteria for exception mentioned in IL 99-3.
3. Companies and individuals that do not have a GST registration number are liable for payment of the Goods and Services Tax on various charges. All registrants must ensure that they provide their GST registration number in writing to the Financial Services Branch @ Fax No. (780) 422-4281.

HOW TO SUBMIT BIDS

1. There are two types of acceptable bids - BID TYPE I and BID TYPE II. The bid formats attached to IL 99-12 are the only ones acceptable. If you fail to conform to the prescribed formats your bid may be rejected.
2. Bids for leases should be enclosed in one sealed envelope with "**Lease Bids - 2004 June 16**" indicated on the outside of the envelope.
3. Bids for licences should be enclosed in one sealed envelope with "**Licence Bids - 2004 June 16**" indicated on the outside of the envelope.
4. Your bid should be handed or mailed to the Manager - P & NG Agreement Sales, at either the Calgary address - 3rd Floor, Monenco Place, 801-6 Avenue SW, T2P 3W2, or the Edmonton address - 7th Floor, Petroleum Plaza North Tower, 9945-108 Street, T5K 2G6,

2. Requesters of parcels posted in this Notice are expected to bid on all postings that they have requested.
3. If you are a requester of a parcel and fail to bid, you will be charged a fee of \$500.00 (plus GST) for each parcel unless it is purchased by someone else.
