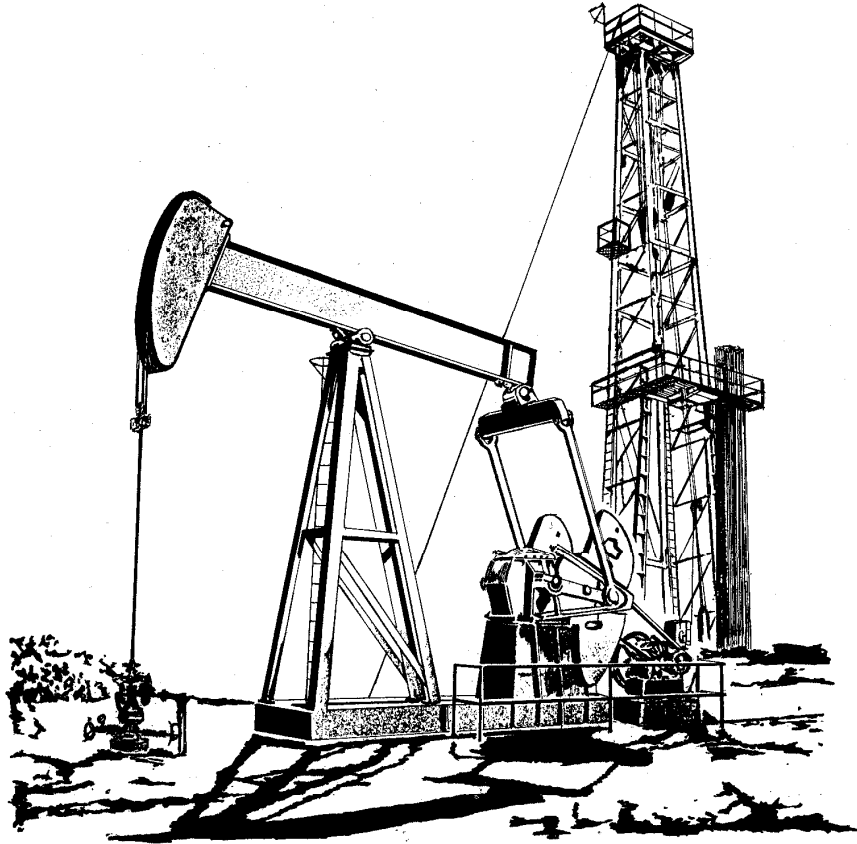

FORM OF PAYMENT
