LATE REPORT PENALTY WAIVER APPLICATION

(Pursuant to the Natural Gas Marketing Regulation)

This document is for use by APMC-600 series reporters that wish to make an application for a waiver of late report penalties pursuant to Section 20(4) of the Natural Gas Marketing Regulation.

A Late Report Penalty Waiver Application may be applied to one or more reporting months if the circumstances given for late reporting are the same for all months. However, if different circumstances for late reporting apply to specific months then a separate Late Report Penalty Waiver Application must be submitted for those months. Applicants are asked to provide a detailed and accurate account of the circumstances which led to their late submission of APMC-600 series report(s).

Late Report Penalty Waiver Application(s) (signed by the person who has applied for the waiver) must be received by Alberta Department of Energy within thirty (30) days from the date of the Penalty Invoice to which the Late Report Penalty Waiver Application applies. Applications will also be accepted by facsimile (403) 297-5400. Applicants who are aware of a pending Penalty Invoice may submit a Late Report Penalty Waiver Application to Alberta Department of Energy prior to receipt of their Invoice.
